**82.1 APOLOGIES:** Apologies were received from N.Kerr,

**82.2 MINUTES OF THE PREVIOUS MEETING:** Minutes of the  
previous meeting were circulated. They were amended to  
record T. Smith's presence and approved.

## 82.3 MATTERS ARISING:

**82.3a PORTOBELLO CENTRE :** N. Stroud reported that despite a  
serious flood last Saturday ,the building was in good state.  
There would be a Public Meeting on 7th November. A clerical  
assistant was being appointed and the Centre needed a  
handyman to act as cleaner/janitor.

**82.3b PORTOBELLO FESTIVAL :** The AGM would be held 9th  
October at 7pm in the Library. Much more help was needed.  
Next year's Festival should be a dress rehearsal for 1992.

**82.3c CONSTITUTION :** There had been no action as yet.

**82.3d CLEAN SAND & SEA :** Cllr. D. Begg reported that he had  
asked Forth River Purification Board to monitor the effluent  
at Joppa.. They had agreed with the Drainage Dept. that the  
cost of the repair to the broken pipe would not be justified.

It was also reported that the new design for the pumping  
station was ready & there would be a meeting with the  
Drainage Dept. shortly. It was hoped to bring the plans to  
the next Council Meeting. Council was asked to note that by  
1998 even the new resources would not satisfy the European  
Regulations.

**82.3e HARRY LAUDER COTTAGE :** Cllr. G. Kerevan had asked  
Council to note that Edinburgh District Council had agreed to  
purchase Harry Lauder Cottage. After considerable discussion  
it was agreed by a large majority to record our support for  
this proposal by writing to the Dept. of Recreation.
